**SWEEPSTAKES ENTRY PERIOD:** The Friendly's x Jonas Brothers Sweepstakes (the "Sweepstakes") begins at 12:00:01 AM Eastern Time ("ET") on Friday, October 27, 2023 and ends at 11:59:59 PM ET on Tuesday, November 14, 2023 (the "Sweepstakes Period").

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the 48 contiguous United States, including the District of Columbia, who are age 18 or older at the time of entry. Void in Alaska, Hawaii, Puerto Rico, Guam, the U.S. Virgin Islands, all other U.S. Territories and Possessions, outside the U.S., and wherever else prohibited by law. privacy policy, which can be found at <https://jonasbrothers.com/privacy-policy/>. **There is a limit of one (1) Jonas Brothers Bonus Entry per person.**

After submitting a Registration Entry, whether the entrant chooses to earn a Friendly's Bonus Entry and/or Jonas Brothers Bonus Entry or not, an entrant may not return to the Sweepstakes Website to earn additional entries or bonus entries.

Registration Entry, Friendly's Bonus Entry and Jonas Brothers Bonus Entry are collectively referred to herein as "Entry" or "Entries". **There is a maximum of three (3) Entries per person. All entries become the property of the Sponsor and will not be acknowledged or returned.

**PRIZE/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:** There is one (1) Grand Prize available to be won. One (1) Grand Prize winner ("Winner") will receive a trip package for two (2) people, Winner and one (1) guest (the "Guest"), to New York, New York to attend a Jonas Brothers concert. Grand Prize trip package includes:

- Round-trip, coach-class air-transportation for Winner and Guest to New York, New York from a major airport within the 48 contiguous United States nearest the winner's residence as determined by Sponsor;
- Two (2) nights hotel accommodations based on a single room with double occupancy;
- Two (2) general admission tickets to the Jonas Brothers concert scheduled to take place on Saturday, December 9, 2023 at the Barclays Center in Brooklyn, New York; and
- One (1) \$300 pre-paid bank gift card.

**The ARV of Grand Prize: 3,000.00.** The ARV may vary based upon dates of travel and point of departure. The difference between the ARV and actual value of the Grand Prize will not be awarded. Odds of winning will depend upon the total number of eligible entries received.

**Prize Conditions:** Grand Prize is not redeemable for cash, assignable, transferable and may not be substituted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. Any other incidental expenses on prize not specified herein, including, but not limited to, meals or ground transportation, are the Winner's sole responsibility. Winner is responsible for all federal, state, local and income taxes associated with winning prize.

Winner's Guest must be legal U.S. resident, 18 years or older, unless Guest is a child of the Winner. Guest must complete and return a Travel Companion Liability & Publicity Release prior to travel as

Sponsor is not the provider of the Jonas Brothers concert scheduled to take place on December 9, 2023 (the "Event"), which is managed or controlled by an independent third party ("Event Sponsor"), and Sponsor has no power to manage or control the operations of Event Sponsor or any third party provider. Sponsor makes no guarantees or warranties about tickets to the Event or the Event itself. The Event Sponsor and its agents or representatives shall not be treated as Sponsor's agents for any purpose, and Sponsor is not responsible for the action or inaction of Event Sponsor, nor is Sponsor liable for any loss or penalties incurred if Event Sponsor is sold, ceases to exist, becomes inoperative, if the Event is delayed, postponed, cancelled or changed for any reason; for acts of nature; for acts of God; or for amenities, services and/or facilities not being available due to renovations, strikes, bankruptcy or for any other reason. Tickets to the Event are issued subject to terms and conditions of the issuing company, which will be listed on the back of the ticket, and subject to these Official Rules. In the case of mechanical difficulties, acts of God, equipment unavailability, celebrity illness or the like, Sponsor reserves the right to work with the Event Sponsor to make a reasonable substitution. If substitution is not possible, Sponsor and/or the Event Sponsor reserve the right to cancel on short notice. If the Event is delayed, postponed, cancelled or changed by Sponsor, the Event Sponsor, a third party, or for any reason, Winner will be notified as soon as possible. If it is not possible to substitute with an alternative date, Sponsor's sole responsibility will be to award the remaining portion of the Grand Prize and no additional substitution or compensation will be provided. Notwithstanding anything to the contrary in these Official Rules or otherwise, Sponsor will not offer cash substitution or refunds or be liable in any way for expenses that Winner incurs related to cancellation of the Event or prize component that has been cancelled by the Event Sponsor, except in its sole and absolute discretion.

Pre-paid bank gift card is not redeemable for cash and will not be replaced if lost or stolen. Pre-paid bank gift card usage is subject to the issuing company's complete terms and conditions, including expiration dates.

**SPONSOR SHALL HAVE NO LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF**

**ANY TRAVEL RELATED TO THE GRAND PRIZE OR ANY OTHER ASPECT OF WINNER'S ACCEPTANCE OR USE OF THE PRIZE.**

**RANDOM DRAWING:** The potential Winner will be selected in a random drawing on or about **Wednesday, November 15, 2023** from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

**WINNER NOTIFICATION & VERIFICATION:** The potential Winner will be notified by the Sweepstakes Administrator, via email and/or phone, and will be required to sign and return, within 48 hours of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). Guest of Winner will also be required to sign a Travel Companion Liability & Publicity Release. Noncompliance will result in disqualification and an alternate winner may be selected.

FURTHER, SPONSOR SHALL NOT BE RESPONSIBLE FOR ANY CANCELLATIONS, DELAYS, DIVERSIONS, CHANGES IN SERVICE OR ACCOMMODATIONS OR SUBSTITUTIONS, OR FOR ANY ACTS OR OMISSIONS BY ANY THIRD PARTIES BEYOND ITS REASONABLE CONTROL, INCLUDING AIR CARRIER(S) AND OTHER TRANSPORTATION COMPANIES; LODGING, RESTAURANT OR OTHER HOSPITALITY PROVIDERS; ENTERTAINMENT PROVIDERS, VENUES OR ARTISTS; OR OTHER THIRD PARTY PROVIDERS SUPPLYING ANY SERVICES OR COMPONENTS OF THE PRIZE(S) TO WINNERS

AND/OR THEIR GUESTS, OR FOR ANY RESULTING INJURIES, INCLUDING MONEY DAMAGES, COSTS AND EXPENSES, PROPERTY DAMAGES, PERSONAL INJURIES OR DEATH RESULTING THEREFROM.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

**DISPUTES:** The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Dallas County, Texas and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place

in Dallas County, Texas. The federal or state law that applies to these Official Rules will also apply during the arbitration.
